Merry Christmas and I hope you will have a prosperous new year.

Most of you may have received information that effective September 2016 all registered, licensed, listed homes the Texas Legislature passed a law which will require for all to pay \$2.00 to DFPS for each background check ,and have an FBI finger print check for you, anyone living in the home 14 yrs and older, and anyone who cares for the children.

The fee is \$41.25 per person. The fee will be paid to the company that takes the fingerprints, not DFPS. More information will be sent about the change.
